**1. TERMS OF THE MEMORANDUM OF UNDERSTANDING**

The scope of the work of the engagement will be to mutually support each other in exchange of human resource and Infrastructure facilities to upscale the knowledge and skills of the students of the Department of Mathematics Dr.M.G.R Educational and Research Institute, University, India and PG Department of Mathematics, Bhaktavatsalam Memorial College for Women.

The scope of work DOES NOT include supply of material resources and DOES NOT have any monetary commitment unless and otherwise both the parties further agree to incur financial resource for any common activity as mutually agreed and executed.

**2. Roles and Responsibilities of FIRST PARTY or Dr. M.G.R. EDUCATIONAL AND RESEARCH INSTITUTE**

- A. The FIRST PARTY would provide its faculty support required by second party in giving guest lecture, organizing workshops, on line classes in the Department of MATHEMATICS when it is requested by the SECONDPARTY.
- B. The FIRST PARTY would collaborate with the SECOND PARTY in jointly organizing Guest lectures, workshops, Symposium, National / International conferences, and Faculty development programs on a commonly agreed theme
- C. FIRST PARTY would collaborate with the SECOND PARTY in identifying areas for research in MATHEMATICS, taking up common research projects or research publications.

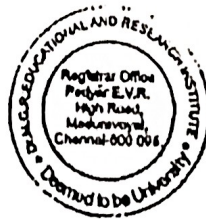

3. **Roles and Responsibilities of the SECOND PARTY (Bhaktavatsalam Memorial College for Women)**
- A. The SECOND PARTY would collaborate with the FIRST PARTY in jointly organizing Guest Lectures, Workshops, Symposium, National / International conferences, and Faculty development programs on a commonly agreed theme.
- B. The SECOND PARTY would collaborate with the FIRST PARTY in conducting Internship, and Mini Project.
- C. The SECOND PARTY would provide support to the FIRST PARTY when the FIRST PARTY offers any training / Certificate courses for the SECOND PARTY.
4. **Deliverables and timelines**  
 Details of the deliverables from both the parties will be worked out separately as per the convenience of both the parties. Postponing, cancellation of the programs on genuine grounds will be as per the discretion of both the parties with the prior information to the other party.
- Credit to any output jointly brought out both the parties should be ensured and certificates, promotional materials, backdrops of seminars would carry the logos and names of both the parties
5. **Commercial terms**  
 There is no financial commitment from both the parties. However, as and when needed subject to financial availability both the parties would share the cost of any common activity undertaken.

**11. Binding obligations**

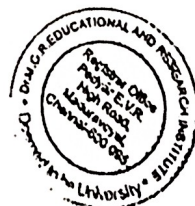

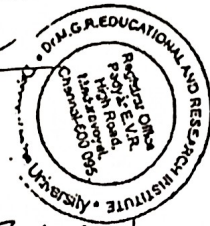
